

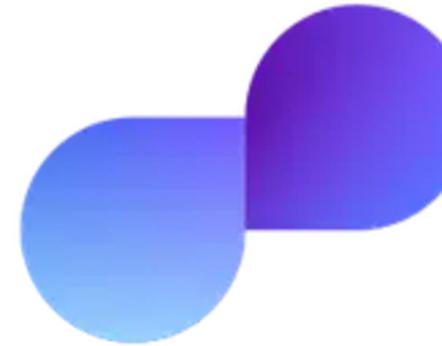

You Have Total Accountability

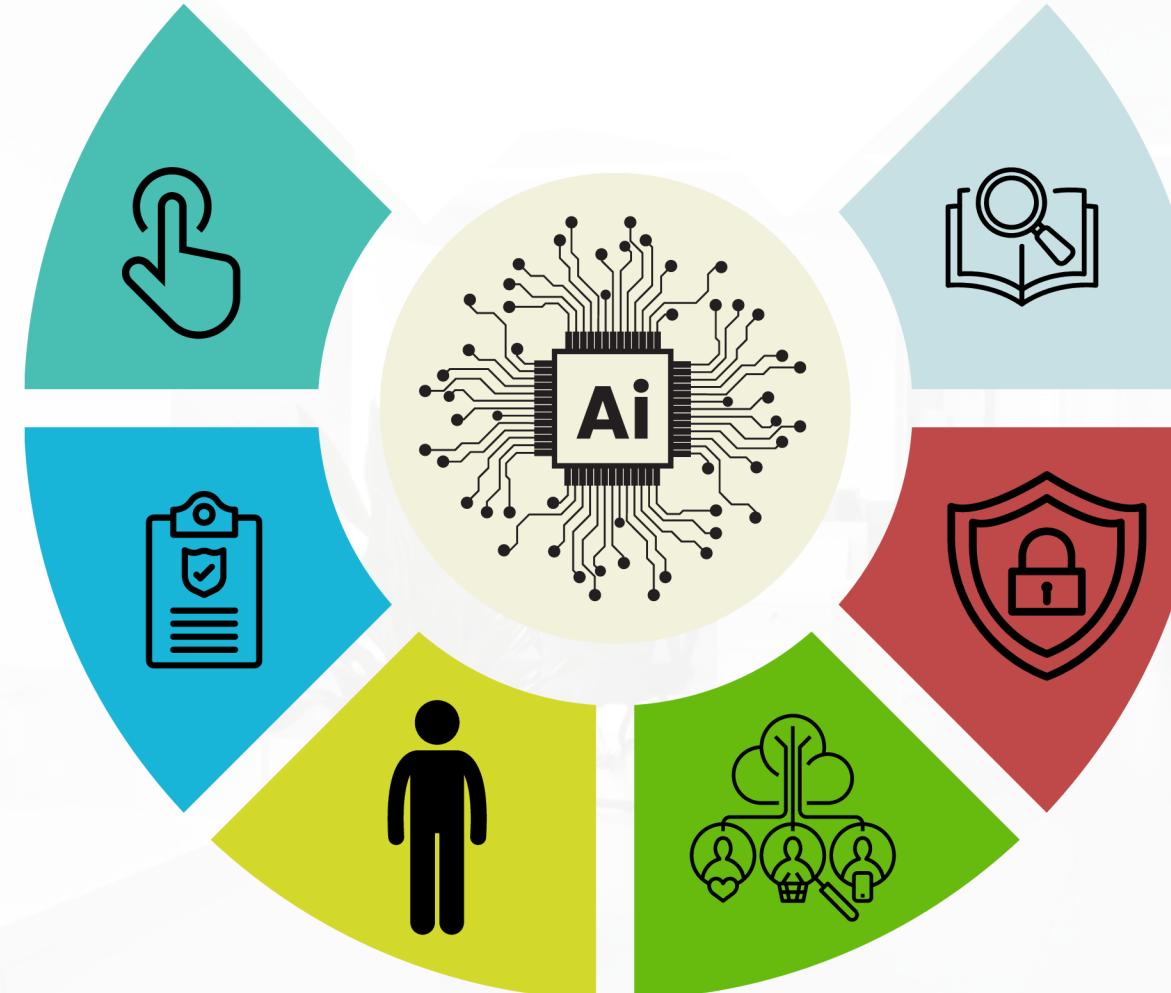
You, the counselor, are always responsible for all clinical decisions and client outcomes, not the AI.

Informed Consent

You must disclose to clients if and when AI is being used. Your consent forms must explain the purpose, limitations , potential risks and benefits , and clients must have the right to opt-out.

Human Oversight

AI must not be used as a replacement for your professional judgment. You must maintain human oversight and review any AI recommendations or treatment plans before applying them.



Competence

Before using an AI tool, you must have a "foundational knowledge" of how it works, its capabilities, and its limitations.

Confidentiality and Privacy

You are responsible for protecting client privacy. This means ensuring any AI tool you use has safeguards , encrypts data , and meets all legal security standards like HIPAA.

Awareness of Bias

You must consider multicultural issues and be careful to ensure the AI tool is not biased in a way that compromises the competent delivery of services

KEY ACTIONS FOR YOUR PRACTICE



Review Your Vendors

Identify every piece of software you use (EHR, note-takers, billing). If they use AI, you must have a BAA from them.



Update Your Informed Consent

Add a section on technology and AI.

Regularly Update Your Policies Regarding AI Usage

Staff training



You Are in Charge

The AI functions like a thoughtful supervisee. AI brings drafts and ideas. You provide the clinical judgment, direction, and final approval. You're always the one ethically and clinically responsible.



Get Competent

Take training on the specific AI tools you use. You must be able to explain their limitations to a client.

Stay Informed

WHAT IS BAA?

- **Business Associate Agreement.**

It is a legal contract required by the Health Insurance Portability and Accountability Act (HIPAA) between:



You

the “**Covered Entity**”
(a counselor, therapist,
clinic, etc.),

The Service Provider

the “**Business Associate**” (any company that creates, receives, stores, or transmits your clients’ Protected Health Information — PHI)

DO I NEED TO SIGN BAA?

- You must have a signed BAA with them before using their services for client data.

- If a BAA hasn't been signed, using a service with PHI in a US healthcare practice would not be considered HIPAA-compliant.



THE HIPAA PRIVACY RULE

INFORM CONSENT

■ **Clear Disclosure of AI Use**

You must disclose if and when AI will be used in their care (NBCC, 2024). This includes identifying all third-party services that use AI (AASCB, 2024).

■ **Purpose and Limitations**

You must explain what the AI is used for and what its limitations are (NBCC, 2024). It's important to make it clear that AI is a tool to assist and "is not perfect," and that "Human oversight is always involved"

■ **Potential Risks and Benefits**

You must inform the client of the potential benefits (e.g., personalized support, efficiency) and the potential risks (AASCB, 2024), such as privacy concerns or tool inaccuracies (AASCB, 2024).

INFORM CONSENT

■ The Client's Right to Opt-Out

You must disclose if and when AI will be used in their care (NBCC, 2024). This includes identifying all third-party services that use AI (AASCB, 2024).

■ Data Handling and Privacy

You should be transparent about your "data access and sharing and retention policies" (NBCC, 2024). This includes explaining how data is collected, securely stored (in a HIPAA-compliant manner), who has access, and how it is deleted (AASCB, 2024).

■ Opportunity for Questions

The consent process must include an opportunity for clients to "ask any questions" (AASCB, 2024) and for you to "Discuss and address any client concerns" about AI and data usage (NBCC, 2024).

HOW TO CHOOSE AND USE AN AI PLATFORM

SOC 2
COMPLIANCE

- SOC 2 is an auditing standard for technology companies that proves they can be trusted to securely manage your data.

HIPAA
Compliance

ISO 27001

- An external, accredited auditor has confirmed that the company has successfully built and is operating an Information Security Management System (ISMS) that meets this strict international standard.

DATA ENCRYPTION

- Encryption is a cybersecurity measure that scrambles plain text so it can only be read by the user who has the secret code, or decryption key (Stouffer, 2023).

How Does Encryption Work?

ADVANCED ENCRYPTION STANDARD (AES)

AES uses both symmetric encryption and a substitution permutation network (SPN) algorithm to apply multiple rounds of encryption. These encryption rounds aid in security, since there are simply too many rounds for a cybercriminal to break through. Cracking a 128-bit AES key can take up to 36 quadrillion years (Stouffer, 2023).

HOW TO CHOOSE AN AI PLATFORM

How They Work

Most platforms get information by 1.) listening live in a telehealth session
2.) uploading a recording
3.) dictating a summary

Pros

The main benefit is reducing the mental effort and barrier to starting documentation, not necessarily saving a massive amount of time. AI is also good at summarizing.

Data Management

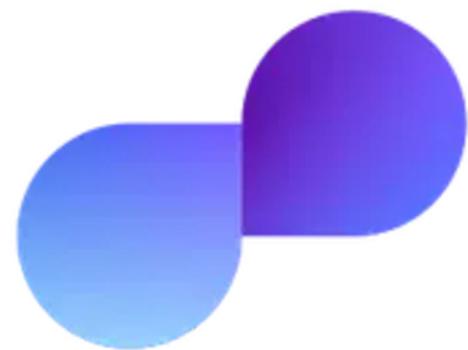
If you use a separate AI tool, you must have a clear process to copy the note to your EHR and then delete it from the AI platform. This prevents having two different versions of a client's record.

Cons

Summaries can be overly long, the technology is new and platforms could be sold or shut down, and there is a learning curve to "train" the AI to write notes the way you want.

Any use involving ePHI requires a HIPAA-compliant generative AI tool with a signed BAA.



What should ChatGPT be used for?



Counselors can safely use ChatGPT for creating generic interventions, building group materials, supporting professional development, drafting administrative documents, generating fictional training cases, creating templates, and asking general ethical or clinical questions such as about ACA ethics, cultural considerations.
